National Groups Announce Expert Peer Panel to Review School Districts Plans for the Fall

Reviewers will highlight promising practice and innovative solutions

Washington, D.C. – Today, the Collaborative for Student Success (CSS) and the Center on Reinventing Public Education (CRPE) announced the names of experts from around the country who will review school district reopening plans in an effort to highlight promising practices in meeting the challenges presented by COVID-19.

Following the release of a <u>planning tool</u> and the launch of a <u>national call</u> for peer reviewers to analyze school district response plans to COVID-19, we received applications from 26 states and the District of Columbia. We have selected 12 distinguished individuals from diverse backgrounds to offer their expert analysis on the strengths of district plans.

Our panel of peer reviewers consists of education expertise at both the state and district levels, representing both rural and urban settings. Additionally, we would not envision a "peer" review of reopening plans without teacher voice at the forefront, so we are pleased to involve classroom educators and a national expert on teacher effectiveness policy.

"The strength of an independent peer review process is the bringing together of voices from differing perspectives and backgrounds to offer sound guidance and analysis." Amanda McAdams, Arizona's 2011 Teacher of the Year, now a district superintendent, continues, "Those of us in the field are confronted with unprecedented challenges right now, and my hope is that districts can learn from one another as this panel identifies the best practices emerging across the country."

To complement the breadth and depth of the education experience this panel of experts offers and recognizing the unique challenges of this unprecedented disruption to our public-school system, we also sought expertise from outside traditional education policy circles. To that end, we welcome a public health expert from George Washington University's Milken Institute, as well as an expert in emergency planning from the American Planning Association (APA).

"I do believe strongly that this pandemic implicates some very serious social equity issues that must be addressed both in remote learning and in any reopening plan. My background in hazard mitigation and disaster recovery will offer a unique perspective in addressing this challenge," said James Schwab, Chair of the Hazard Mitigation and Disaster Recovery Planning Division of APA.

In acknowledging that parents and students are at the heart of school plans' impact, the panel includes expertise in parent and community advocacy as well as the unique issues faced by students with special needs. We round the panel out with an expert in school finance, as school reopening discussions are likely to be burdened by budgetary limitations.
